## Participating in LifeWave®

As a LifeWave Brand Partner, you can participate by:

- Selling LifeWave products to your customers
- Developing Preferred Customers who purchase products every month
- Finding others who want to consume or sell LifeWave products
- Buying LifeWave products at a discount for your own or household use

## **Cost to Register and Renew**

You do not need to purchase products to become or remain a Brand Partner. The enrollment fee is \$25.

## **Direct Selling as a Brand Partner**

The LifeWave opportunity is based on product sales. As a LifeWave Brand Partner, you cannot earn commissions by merely sponsoring or recruiting others. You can earn in the following ways:

- 1. You can apply retail markup on products you sell to customers; and
- 2. You can earn sales commissions based on your product sales and the product sales of Brand Partners in your sales organization.

Your success in the LifeWave sales opportunity will vary. Many factors are involved, including your customer base, your skills, business experience, effort, persistence, and the quality and extent of your sales organization.

## How Much Can You Earn?

For Brand Partners who were registered with LifeWave and active, 23% received a commission payment from LifeWave in at least one month for sales that occurred in 2023. The expenses a Brand Partner incurs in the operation of his or her LifeWave business vary widely. Expenses for Brand Partners can be several hundred or thousand dollars annually. You should factor in estimated expenses when projecting potential

profits. Such operating expenses could include advertising and promotional expenses, product samples, training, travel, telephone and Internet costs, business equipment, and miscellaneous expenses.

• 18% of Brand partners did not earn any compensation during the year because they were not active. An "active Brand Partner" means that the Brand Partner sponsored someone, purchased products, or earned commissions during 2023.
